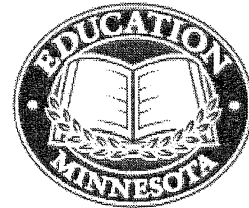

## CONTRACT CORNER

Whew, you made it! It is finally lunchtime in your day and time for some "ME" time. But what if it seems like your lunchtime isn't "All About You?" The contract states that all teachers should have a duty-free lunch of approximately 30 minutes (page 5, Section 5-The Basic Day.)

"Duty-free" means non-working-no parent calls, no email checking, no grading, no meetings with colleagues or administration and no keeping students with you for whatever reason you feel you should. If you CHOOSE to do these things with your lunchtime, it is voluntary. The association would strongly encourage you to get your socialization needs met with colleagues, get out of your workspace for a bit and truly relax while eating and refresh for the challenges of the rest of your day with students. We know this is very hard to do, as we all want to do the work well and there is just not enough hours in the day to get it all done and prep time is not a break. Please know that your association supports you in your need for balance and a true break each day. If you are being expected to use your lunchtime to handle work related responsibilities, please discuss this with your building representative and /or member rights representative if you are unable to get this resolved at the building level.

"Approximately 30 minutes" leaves some room for interpretation, unfortunately. We know at some buildings, teachers have only about 25 minutes before students are released and needing supervision in the hallways as they get their things and head for class. Other buildings seem to have more than 30 minutes (more like 40 minutes) but that often includes escorting students to lunch and assisting them until they are seated in the lunchroom. Since the contract states this amount of time as an approximation, such inequities seem to be justifiable, however anything less than 25 minutes should be brought to the attention of your member rights representative. Here's to delightful, daily dining!

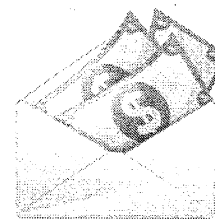

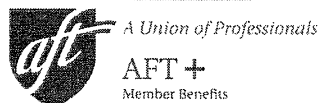
